**Filling data gaps in the measurement of development support:**

*The event will present the main findings of the [2022 TOSSD data collection on 2021 activities of development support](#). It will also showcase the latest developments to expand data coverage of the TOSSD framework. Finally, it will call on more countries and organisations to join the TOSSD initiative to further increase transparency, including through SDG indicator 17.3.1, on the measurement of development support.*

**In 2022, TOSSD was included as a data source in the SDG global indicator framework to measure development support.** This was an outcome of work by the IAEG-SDGs “Working Group on Measurement of Development Support”<sup>1</sup>, created at the request of the UN Statistical Commission<sup>2</sup>, with wide country and UN-System participation. The Working Group developed a proposal for a new indicator 17.3.1, with TOSSD as a data source. Early March 2022, the UN Statistical Commission approved this new indicator<sup>3</sup>, and requested the OECD and UNCTAD to be its co-custodians.

**The third TOSSD dataset was released in January 2023, with activity-level information from more than 100 provider countries and institutions on their 2021 support for sustainable development. These data address critical sustainable development information gaps for developing countries and beyond.** The TOSSD framework increases visibility and transparency on contributions made by both traditional providers and dual providers/recipients. It also captures regional and global expenditures for sustainable development with substantial benefits to developing countries (e.g. R&D to fight against infectious diseases). Without this information, it will remain challenging to design efficient global, regional and local responses to support these countries in achieving their development goals. Moreover, TOSSD data can help countries that present at the HLPF their Voluntary National Reviews (VNRs) on the implementation of the SDGs<sup>4</sup>.
