The session will then be structured around specific questions posed by Task Force members ahead of the meeting and regarding activities that they are unsure about whether and how to report them. **Task Force members are kindly invited to send their questions ahead of time - and by Monday 21 June COB at the latest - to leave the Secretariat time to prepare responses.** Priority will be given to questions by emerging providers and questions that are particularly relevant to improve the quality of reporting for all TOSSD reporters (e.g. reporting on COVID-related activities, integration of migrants, delineation pillar I vs pillar II).

13h00 Item 2. Provider perspective

While TOSSD measures sustainable development finance from a recipient perspective, providers have expressed their wish to be able to present TOSSD from a provider perspective, i.e. the TOSSD resources originating from their country or that were generated through their membership and contributions in the multilateral system. The Secretariat will provide a short paper flagging the main questions that will need to be addressed to define this perspective, noting that a TOSSD provider pilot study is currently ongoing with Chile. **Members will be invited to react to the paper and provide guidance to the Secretariat on a way forward.**

11h35 Item 4. Update on the financing of TOSSD and the Task Force

At the last meeting in March 2021, the Secretariat indicated that it would reach out to a number of Task Force members to investigate further the issue of financing of TOSSD, including the possibility for each member to fund the framework, their possible level of financing, their funding processes and timetable, etc. The Secretariat will report on the various meetings held with members. The Task Force **will be invited to comment on the findings of these calls and provide any further perspective on the possibility for them to fund TOSSD in 2021 and beyond. The perspective of emerging providers and recipient countries will be particularly sought during this session.**

This session will aim to gather **views and ideas from Task Force members, especially recipient countries, as to which options could be operationalised in TOSSD to ensure a review of data by recipient countries.** The outcomes of this discussion will be useful to inform the IAEG-SDGs working group on the measurement of development support and the data pilot that the Task Force Secretariat is currently carrying out with three countries (Cameroon, Colombia and Bangladesh).
