

Item 8. Update on the implementation of the TOSSD communication and outreach strategy July 2022 – December 2023¹

Introduction

- 1. The TOSSD communication and outreach strategy for the period July 2022 December 2023 was presented to the Task Force at its 17th meeting in July 2022². It is structured around four objectives:
 - a. More countries and organisations report activity-level, quality data, to TOSSD in 2022 and 2023, in particular to inform the SDG indicator 17.3.1.
 - b. Increased usage of TOSSD data to inform development finance decision-making and discussions.
 - c. Targeted audiences have increased their knowledge on the basic concepts contained in the TOSSD methodology.
 - d. Targeted audiences are sensitised about the future TOSSD governance arrangement and its rationale.
 - 2. This paper takes stock of progress towards the above objectives using the agreed performance indicators per objective (section I). The paper then presents the main challenges faced and best practices identified during the implementation of the strategy (Section II). Finally, the paper suggests a way ahead, considering the overall objectives of the TOSSD Task Force until December 2023 and beyond (Section III).

I. Progress on the four objectives of the strategy


3. The Secretariat has prepared the following matrix to report on the progress made on the expected outcomes and indicators of the Communications and Outreach strategy.

II. Main lessons learnt from the period July 2022-February 2023

- 4. The TOSSD presence on social media is increasing exponentially as shown by the number of likes, retweets and reposts on social media. At the same time, increased TOSSD visibility on social media also proves to be more time-consuming than expected. The Secretariat nevertheless believes it is a very helpful, impactful and complementary way to the traditional direct outreach (e.g., meetings, phone calls) to the TOSSD community. It is encouraging that, for example, the UN Office for South-South Cooperation (UNOSSC) and some of its senior level representatives have retweeted TOSSD-related posts on SSC. Also, increased presence on social media is helpful to identify and approach new reporters.
- 5. Data stories are a good way to showcase what target audiences can do with TOSSD data. During the period July 2022-February 2023, the Secretariat prepared four data stories and two infographics on TOSSD and launched a renewed section on TOSSD.org to host these products. In 2023, three data stories will be developed, with full dissemination on social media and more formal arenas.
- 6. Further efforts should be made to ensure that TOSSD, with its recipient perspective, is effectively used by TOSSD recipient countries. Task Force members have a major role to play in this regard. In the top-20 countries in terms of number of users on TOSSD.online, there are only four TOSSD recipients (Brazil, China, India and Mexico) which are, at the same time, major South-South cooperation providers. The first TOSSD recipient that is not a major SSC provider (Côte d'Ivoire) is only ranked 27. The Secretariat will host capacity building seminars for "TOSSD recipients" and "recipient countries presenting VNRs at the 2023 and 2024 HLPFs" in the course of 2023 and 2024. Continuous engagement on social media as well as references in political outcome documents of key conferences and political arenas (e.g., FfD Forum, HLPF, UNGA) should be further promoted to achieve a higher usage of TOSSD data by TOSSD recipients.
- 7. Ensuring that current reporters to TOSSD do not drop out must also be a priority. Six countries and organisations that reported data on their TOSSD in 2020 have not yet submitted data for 2021⁵, despite the Secretariat's regular follow-up. This requires dedicated outreach that should not be underestimated.
- 8. From a regional and strategic standpoint, the Secretariat and the Task Force need to increase efforts to bring in more TOSSD reporters from Southeast Asia. In the 2022 data collection round, while major progress was made with countries in Latin America, Thailand was the only provider from Southeast Asia. The Secretariat will undertake a range of activities to strengthen engagement with providers in this region (capacity building seminars, invitations to TOSSD-related events, business intelligence with some partners of the Secretariat, among others).

9. There is a growing body of evidence of TOSSD references. Even though it is not an indicator of the Strategy, the Secretariat also monitors where TOSSD is referenced (e.g., articles, books, official documents, papers). In 2022, TOSSD was referenced in 16 publications (vs. 7 in 2021 and 10 in 2020). This shows that TOSSD is becoming more prominent across governments, academia and think tanks. The monitoring of TOSSD discussions on social media and beyond is helping the Secretariat to address questions, doubts and concerns about the TOSSD framework and gain more experience on how to address different communities.

III. The way ahead – next steps

- 10. The Secretariat will continue the implementation of the Outreach and Communications Strategy approved by the Task Force, with special focus on certain communities and groups of countries and organisations.
- 11. The Secretariat suggests putting particular emphasis on the following results:
 - a. Increased inclusion of TOSSD data in VNRs for 2023, 2024 and 2025 HLPFs. To do so, the Secretariat has planned two online capacity building seminars. The Secretariat will invite representatives from countries reporting in those HLPF editions from the Ministries of finance, planning, development co-operation and the National Statistical Offices.
 - b. **Increased use of TOSSD.online by TOSSD recipient countries**. To do so, the Secretariat will prioritise recipient countries submitting VNRs in the 2023 and 2024 HLPFs, and foster engagement through, for example, invitations to the launch of TOSSD data at the FfD Forum, side events in other global conferences, and capacity building seminars.
 - c. Increased number of countries and international organisations reporting to TOSSD, through outreach to potential new reporters, avoiding dropouts and bringing back reporters that temporarily discontinued their reporting. The Secretariat will also have a special geographical focus on Southeast Asia until at least December 2023.
 - d. **Increased awareness about the future governance arrangement of TOSSD** and the rationale for its creation.
